Press Release

The US Embassy invites the Teachers Committee in Sudan to a Meeting Rulers of Sudan, where are you? What humiliation have you brought us to?!

(Translated)

It was stated in Al-Sudani newspaper issued today, Tuesday 10/1/2023, and in other media outlets, that the Executive Office of the Sudanese Teachers Committee received an invitation from the US Embassy in Khartoum to hold a joint meeting, and the committee indicated in a brief statement yesterday evening that the meeting aims to discuss some issues related to Education, and the repercussions of the current teachers' strike. The committee said that the Executive Office will accept the invitation, and then announce the outcomes of the meeting and make them available to all teachers.

We know that our country, Sudan, and other Muslim countries, do not control matters of governance and politics in it, whoever is in power. Rather, they are mere agents who implement the dictates of the colonial Kafir (disbelieving) West in our country, but we did not expect the matter to be so insolent. For the American embassy to interfere in a purely internal matter, and even invite some of the state's citizens who have demands. The rulers of Sudan are the ones that should discuss and implement them, not to be discussed by the US Embassy that claims to be resolve with them!

We in Hizb ut Tahrir / Wilayah of Sudan reject this blatant interference and demand the following:

First: The American ambassador must be expelled, and his country's embassy closed immediately. because the Islamic State (the Khilafah) does not allow the presence of embassies of the colonial countries in our country. Article 189 of the Draft Constitution of the Khilafah State prepared by Hizb ut Tahrir states the following: "Third: The countries with which we do not have treaties and the actual colonial states such as England, America and France, and the states that crave our country, such as Russia, are considered warring states by law, so all precautions are taken with regard to them and it is not right to establish any diplomatic relations with them ... "

Second: It would have been more appropriate for you, brothers in the Sudanese Teachers Committee, to reject this invitation, not to accept it, because by agreeing to sit with the American embassy, you have betrayed your cause, and betrayed your brothers teachers who are scattered in all parts of Sudan, for it is a thousand times more honorable for them to remain struggling for their cause until the sincere rulers come to power, and resolve all issues, than to rely on the Kafir enemy to beg for a solution from him.

Third: The government must be serious in resolving the teachers' issues and others, and not allow them to beg for rights, especially in terms of living, as Sudan is rich in its resources. If there is someone who can utilize the resources in the interest of the Ummah, and not be of assistance to the colonial Kafir in plundering the wealth of the country and impoverishing the people, and humiliating them until they are forced to sit with the enemy.

In conclusion: We are certain that the current government, and even the previous one, and even the one that will come through the ill-fated framework agreement, will not solve the problem for the people, nor will there be a decent life for them, so everyone must work for real change which takes us out of the power of the colonial Kafir, its agents and aides. And that is by working diligently with Hizb ut Tahrir, the pioneer who does not lie to its people, and who strives through you and with you to establish the second Khilafah Rashidah (rightly guided Caliphate) on the method of the Prophethood that establishes a life of honor and dignity, and cuts off the hand of the colonial Kafir so that the Lord of Glory (swt) will be pleased with us.
